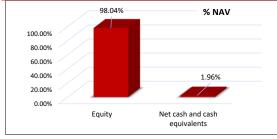

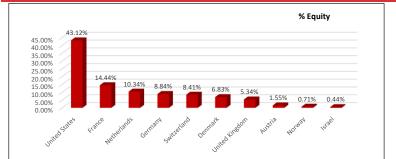

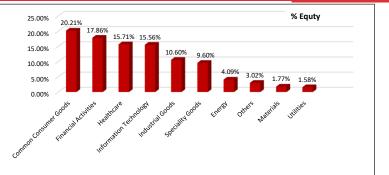

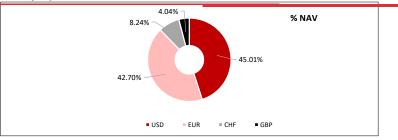




Sectoral Exposure
