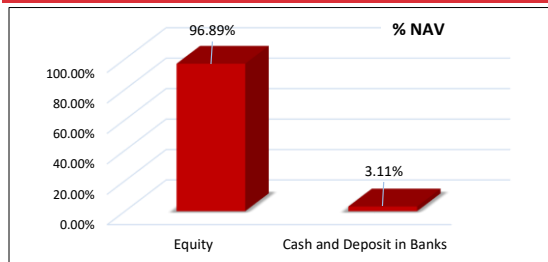

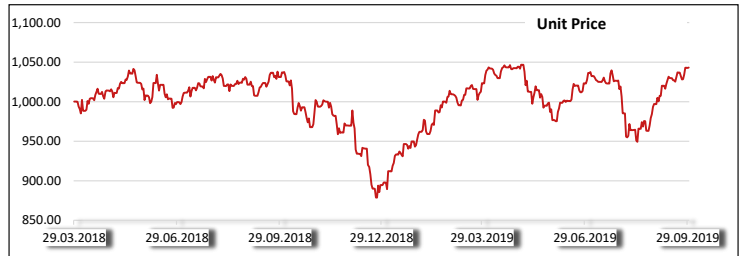

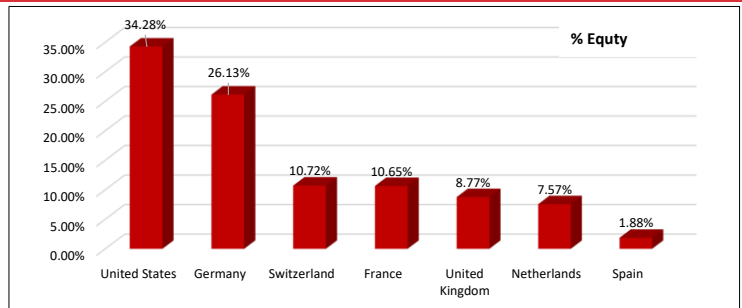

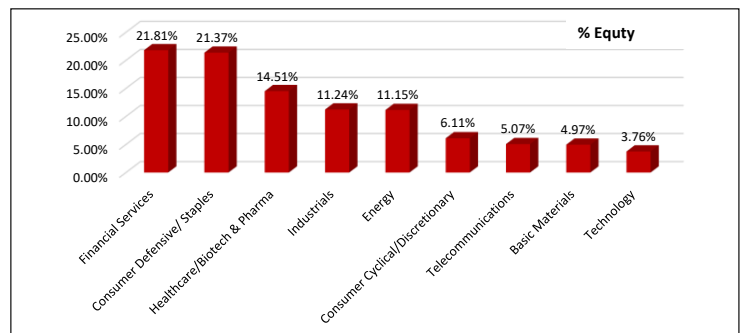

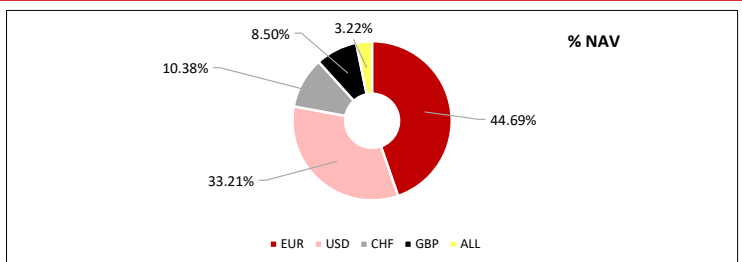
Geographic Exposure
